11 12 13	Amend the bill by striking out all of section I (page 2, lines 9 to 14 in L.D.) and inserting in its place the following:
14 15 16 17 18	'Sec. 1. Raise money for new extension facility. The county commissioners of Waldo County are authorized to raise and expend a sum not exceeding \$80,000 for the construction of a Waldo County extension service building.'
19 20 21 22	Further amend the bill in section 3, in the 9th line (page 2, line 32 in L.D.) by striking out the words "Capital Improvement" and inserting in their place the words 'Extension Service Building'
23 24 25 26	Further amend the bill in section 3, in the 12th line (page 2, line 35 in L.D.) by striking out the word "thereof" and inserting in its place the words 'of issue'
27 28 29	Further amend the bill in section 3, in the 13th line (page 2, line 36 in L.D.) by striking out the figure "20" and inserting in its place the figure '8'
30 31 32	Further amend the bill in section 3, in the 14th line (page 2, line 37 in L.D.) by inserting after the word "date" the words 'of issue'
33 34 35	Further amend the bill in section 3, 3rd line from the end (page 3, line 1 in L.D.) by inserting after the word "shall" the word 'not'

Further amend the bill in section 3, by inserting 2 at the end the following paragraph: 'If any bonds have not been issued within 5 years of ratification by the voters, those bonds shall not If any proceeds from the sale of the 5 be issued. bonds have not been expended within 10 years after the date of sale, those proceeds shall lapse to the 6 8 county's debt service account. 9 Further amend the bill in section 5, in the 2nd 10 paragraph, in the 4th line (page 3, line 28 in L.D.) by inserting after the word "question" the following: 11 , with the accompanying statement concerning esti-12 mated debt service' 13 14 Further amend the bill in section 5, by striking 15 out all of the question and inserting in its place 16 the following: 17 '"Do you favor an \$80,000 bond issue to construct 18 a county-owned building to house the County Ex-19 tension Services?"' 20 Further amend the bill in section 5, by inserting 2.1 after the question the following: 22 'The total estimated debt service for this issue 23 is \$107,500 of which the principal is \$80,000 and the 24 estimated interest is \$27,500 at an average rate of 25 7.28% for 8 years. Waldo County currently has no bond indebtedness.' 26 27 Further amend the bill in section 5, in the 2nd paragraph from the end, 7th line (page 4, line 2 in L.D.) by striking out the word "next" and inserting in its place the word 'last' 28 29 30 Further amend the bill by striking out all of the 31 32 emergency clause and inserting in its place the fol-33 lowing:

1 2 3 4	'Emergency clause. In view of the emergency cited in the preamble, this Act shall take effect when approved, only for the purpose of its submission to the voters of Waldo County.'
5	STATEMENT OF FACT
6	This amendment accomplishes the following:
7 8	1. Eliminates the confusion as to whether the bill requires a referendum;
9 10 11	 Adds a provision as to action to be taken if the bonds are not issued or the funds not expended within specified time periods;
12 13 14	3. Changes the referendum question to indicate the amount of interest to be incurred and to indicate the current bond debt status of the county; and
15	4. Makes a number of minor wording changes.
