STATEMENT OF FACT

17 This bill amends the law concerning exemption 18 from sales tax for meals provided to individuals utilizing the services of commercial guides 19 and 20 whitewater outfitters, where such meals are prepared and served in the field and constitute an integral and necessary aspect of the service which such li-21 22 censed guides and outfitters provide. The purpose of 23 24 this bill is to incorporate within the exemption pro-25 visions of the sales and use tax law, the exemption from sales tax obligation, the incidental provision 26 of meals, by guides and outfitters 27 that has implicitly been traditionally recognized. 28
