word 'ADVISORY'

by inserting after the underlined word "Budget" the
underlined word 'Advisory'

Further amend the bill in that part designated
"§1402." by striking out all of the first paragraph

'In Kennebec County, there is established the
Kennebec County Budget Advisory Committee to carry
out the purposes of this chapter. This chapter ap-
plies only to Kennebec County.'

Further amend the bill in that part designated
"§1402." by striking out all of subsection 1 and in-
serting in its place the following:

'1. Membership. The budget advisory committee

1 shall consist of 9 members, 3 members from each com-
2 missioner district to be appointed by the county com-
3 missioners. The term of each member of the budget ad-
4 visory committee shall be for 2 years.'

5 Further amend the bill in that part designated
6 "§1402." in subsection 2, in the 2nd line (page 3,
7 line 39 in L.D.) by inserting after the underlined
8 word "budget" the underlined word 'advisory' and in
9 the 4th line (page 3, line 41 in L.D.) by striking
10 out the underlined word "approve" and inserting in
11 its place the following underlined words 'make recom-
12 mendations to the county commissioners concerning'

13 Further amend the bill in that part designated
14 "§1402." by striking out all of subsections 3, 4 and
15 5 and inserting in their place the following:

16 '3. Vacancies. A vacancy occurring on the budget
17 advisory committee shall be filled by appointment by
18 the county commissioners for the balance of the unex-
19 pired term. The person appointed to fill the vacant
20 office shall be a municipal officer from the same mu-
21 nicipality as the person vacating the office.

22 4. Expenses. Members shall serve without compen-
23 sation, but shall be reimbursed from the county trea-
24 sury for expenses lawfully incurred by them in the
25 performance of their duties.'

27 ing: "budget, provided that:" and inserting in its
28 place the following: 'budget.'

34 line 9 in L.D.) by inserting after the underlined
35 word "budget" the underlined word 'advisory'

36 Further amend the bill in that part designated
37 "§1404." by striking out all of subsection 4 and in-

2 '4. Adoption of budget. After completion of the
3 public hearing, the county commissioners may further
4 increase, decrease, alter and revise the proposed
5 itemized budget, provided that:

6 A. The county commissioners shall enter into
7 their minutes a statement of the basis for any
8 rejection of any recommendation of the budget ad-
9 visory committee; and

10 B. The total estimated revenues, together with
11 the amount of county tax to be levied, shall
12 equal the total estimated expenditures.

13 The recommended budget shall then be transmitted by
14 the county commissioners to the Legislature for its
15 approval. The county tax authorized shall be appor-
16 tioned and collected in accordance with section 254.'

17 Further amend the bill in that part designated
18 "§1405." by striking out all of the first paragraph
19 and inserting in its place the following:

20 'The approved budget shall govern the expendi-
21 tures of the county during the fiscal year. No ex-
22 penses may be incurred in excess of those shown in
23 the approved budget, but the budget may be from time
24 to time revised by the commissioners with the advice
25 of the budget advisory committee.'

26 Further amend the bill by adding at the end be-
27 fore the Statement of Fact the following:

28 '§1407. Repeal

29 This chapter is repealed on September 30, 1988.'

STATEMENT OF FACT

2 The purpose of this amendment is to create a Ken-
3 nebec County Budget Advisory Committee. The members
4 of this committee will be appointed by the county
5 commissioners, rather than going through a costly
6 election process. The amendment places the committee
7 in an advisory position only.
