STATE OF MAINE

IN THE YEAR OF OUR LORD
NINETEEN HUNDRED AND EIGHTY-FIVE

AN ACT to Transfer from the Bureau of Public
Lands to the Baxter State Park
Authority the Designation as the
Agency of the State to Receive Funds
Donated by Governor Percival P.
Baxter.

Be it enacted by the People of the State of Maine as follows:

Sec. 1. 12 MRSA §560, as enacted by PL 1983, c. 819, Pt. A, §11, is repealed.

Sec. 2. 12 MRSA §901, 2nd ¶, as enacted by PL 1969, c. 557, §3, is amended to read:

The authority is further designated the agency of the State to receive such sums as are, from time to time, paid to the State by the trustee under clause THIRD of a certain inter vivos trust dated July 6, 1927, as from time to time amended, created by said Baxter for the purchase or other acquisition of addi-

1 tional land for said Baxter State Park, and for the
2 purchase of other lands for recreational or reforest-
3 ation purposes, and the authority is authorized to
4 expend such sums so received for such purposes and
5 shall hold and use such lands as specified in the
6 trust.

7 STATEMENT OF FACT

8 The intent of this bill is to more closely imple-
9 ment the directives of Governor Percival P. Baxter as
10 set forth in the THIRD clause of his inter vivos
11 trust dated July 6, 1927, as amended May 18, 1966,
12 and further to recognize that the Baxter State Park
13 Authority, as trustee for the Baxter State Park and
14 as such responsible for administering the principal
15 object of this part of the trust, is the most appro-
16 priate state agency to receive additional funds for
17 the purchase of other lands as specified in the
18 trust.
