373, L.D. 492, "Resolve, to Name the Wiscasset Bridge
the Donald E. Davey Bridge."

Amend the resolve by striking out all of the title and inserting in its place the following:

'AN ACT to Authorize the Maine Historic Preservation Commission to Name Bridges.'

Further amend the resolve by striking out everything after the title and inserting in its place the following:

'Sec. 1. 23 MRSA §356 is enacted to read:

§356. Naming of bridges

The Maine Historic Preservation Commission may name bridges that are maintained by the State.

Sec. 2. 27 MRSA §504, sub-§§1 and 2, as repealed and replaced by PL 1979, c. 21, are amended to read;

1. Administration. The steps which are necessary and relevant to encourage and stimulate public interest and participation in the historic, architectural and archaeological heritage of our State, and to advise the State Historic Preservation Officer with regard to liaison between the State and Federal Governments and public or private agencies or organizations interested in and participating in the field of historic preservation; and

2. Programs. The steps which are necessary to administer the program of the National Historic Pres-
