Amend the Amendment by striking out all of the 10 11 first paragraph after the title and inserting in its 12 place the following: 13 'Amend the Bill by inserting before the enacting 14 clause the following: 15 'Emergency preamble. Whereas, Acts of the Legis-16 lature do not become effective until 90 days after adjournment unless enacted as emergencies; and 17 18 Whereas, it is desired to obtain the benefits of 19 participation by local officials at the earliest pos-20 sible time; and 21 Whereas, the budget committee by terms of this 22 Act must be elected at least 90 days prior to the end 23 of the fiscal year; and 24 Whereas, in the judgment of the Legislature, 25 these facts create an emergency within the meaning of 26 the Constitution of Maine and require the following 27 legislation as immediately necessary for the preser-28 vation of the public peace, health and safety; now, 29 therefore, Further amend the Bill by striking out all of that part designated " $\underline{\$1401.}$ " and inserting in its 30 31 32 place the following: 33 '§1401. Purpose 34 The purpose of this chapter is to establish in

1 Aroostook County a method of appropriating money for county expenditures, including expenditures for mu-2 3 nicipal services in the unorganized territory, ac-4 cording to a budget, which shall first be adopted by 5 a budget committee and shall then be approved by the 6 Legislature. This chapter amends the present statuto-7 ry method in sections 252 and 253 by creating a committee elected by Aroostook County municipal officers 8 with authority to adopt or amend the budget. The Leg-islature shall continue to have authority to approve, 9 10 but not to amend, the budget. This chapter applies 11 12 only to Aroostook County.

13 Further amend the amendment by inserting after 14 the 2nd paragraph after the title, the following:

15 'Further amend the bill in that part designated 16 "<u>§1403.</u>" in subsection 1, paragraph A, by striking 17 out all of the 2nd sentence and inserting in its 18 place the following:

19 'A county commissioner shall serve as nonvoting mod-20 erator for his district caucus.'

Further amend the bill in that part designated <u>§1403.</u>" in subsection 1, paragraph B, in the 3rd line (page 3, line 12 in L.D.) by striking out the underlined word "their" and inserting in its place the underlined word 'his'

Further amend the bill in that part designated "§1403." in subsection 1, paragraph D, in the 2nd and 3rd lines (page 3, lines 35 and 36 in L.D.) by striking out the underlined words and punctuation "budget, estimates, including the budget for" and inserting in their place the words and punctuation 'budget and estimates, including the budget for municipal services in'

1 'Further amend the Bill in that part designated "§1405." by striking out all of subsection 4 and in-2 3 serting in its place the following: '4. Adoption of budget. After completion of the 4 5 public hearing, the budget committee may further in 6 crease, decrease, alter and revise the proposed itemized budgets, subject to the conditions and restric-tions imposed in subsection 2. The proposed itemized budget shall be finally adopted by a majority vote of the budget committee at a duly called meeting not la-ter than the end of the county's fiscal year. 7 8 9 10 11 12 Final budget approval. Prior to January 15th 5. 13 of the fiscal year for which the budget is prepared, 14 the budget committee shall submit the proposed budget 15 to the Legislature. The Legislature shall approve or 16 disapprove the budget as submitted prior to April 1st 17 of each year. the Legislature disapproves of the budget, the 18 Ιf budget committee shall submit within 15 calendar days, new budget proposals in accordance with subsec-19 20 21 tion 1 and the provisions of this section shall be 22 followed until a budget is finally approved. 23 The budget as approved by the Legislature shall be 24 the final authorization for the assessment of county 25 taxes. The budget shall be transmitted to the county 26 commissioners and the county tax authorized shall be 27 apportioned and collected in accordance with section 28 254. 2 Further amend the Bill in that part designated 3 "§1406." by striking out all of the 3rd underlined 4 sentence and inserting in its place the following: 5 'The budget committee shall within 15 calendar days 6 approve, disapprove or amend this revised budget. In the event that the proposed revised budget is approved or amended, the budget committee within this 7 8 same time period shall forward the revised budget to 9 the Legislature for final approval. The Legislature shall have 15 calendar days to render a decision on the revised budget.' 10 11 12

Further amend the Bill in that part designated "§1406." in the next to the last line and the last line (page 6, lines 10 and 11 in L.D.) by striking out the following: "the budget committee's action" and inserting in its place the following: 'an approval of a revised budget by the Legislature' '

19 Further amend the Amendment by inserting after 20 the 7th paragraph after the title the following:

21 'Further amend the Bill by inserting at the end 22 before the Statement of Fact the following:

23 'Emergency clause. In view of the emergency cited 24 in the preamble, this Act shall take effect when ap-25 proved.''
