## COMMITTEE OF CONFERENCE AMENDMENT "heta" to s.p. 321, L.D. 810

This conference committee amendment will provide substantial cost savings and will avoid duplication of effort in preparing the revision. The conference committee amendment also reduces the allocation to \$15,000 to reflect the savings. It is estimated that \$5,000 of this allocation will be required for per diem, public notice and printing costs of the commission. This conference committee amendment also adds 2 more state agency representatives to the recodification committee.
