17 AN ACT to Adjust the Boundaries between House  
18 District 103 and House District 55.  
19

20 Be it enacted by the People of the State of Maine as  
21 follows:

22 21 MRSA §1571-B, sub-§5, House Districts 55 and  
23 103, as amended by PL 1983, c. 862, §68, are further  
24 amended to read:

25 District Number 55, consisting of the municipali-  
26 ties of Carrabassett Valley, Coplin Plantation,  
27 Dallas Plantation, Eustis, Industry, Kingfield,  
28 Madrid, New Vineyard, Phillips and Strong, and  
29 the unorganized territories of East Franklin  
30 County, North Franklin County, and Wyman Town-  
31 ship, in Franklin County, the municipalities of  
32 Embden, Highland Plantation and New Portland, and  
33 the unorganized ~~territories~~ territory of Central  
34 Somerset County, known as Lexington and ~~Conecord~~  
35 Townships Township in Somerset County.

1 District Number 103, consisting of the municipal-  
2 ities of Anson, Athens, Bingham, Brighton  
3 Plantation, Caratunk, Dennistown Plantation,  
4 ~~Highland Plantation~~, Jackman, Moose River,  
5 Moscow, Pleasant Ridge Plantation, Solon, The  
6 Forks Plantation, West Forks Plantation and the  
7 unorganized territories of East Somerset County,  
8 North Somerset County and West Somerset County,  
9 and the unorganized territory of Central Somerset  
10 County, known as Concord Township in the County  
11 of Somerset.

12 STATEMENT OF FACT

13 The purpose of this bill is to move Highland  
14 Plantation from House District 103 to House District  
15 55, and to move Concord Township from House District  
16 55 to House District 103.
