1 after having given his personal recognizance being 2 duly served with a subpeona under section 3123, sum-3 mary process shall issue by order of the judge, re-4 quiring the judgment debtor to appear for a hearing 5 on a day certain and show cause why he shall not be 6 adjudged guilty of contempt and be punished by such 7 reasonable fine or imprisonment as the circumstances require. In addition, the judgment creditor may pro-8 9 ceed ex parte and the court may enter orders pursuant 10 to sections 3127, 3130, 3131, 3132 and 3137, except 11 that no earnings shall be subject to an installment 12 payment order under section 3127 or an order to an employer or payor of earnings under section 3137 ex-13 14 cept for the excess of earnings over \$100 per week.
