10 11 12	Amend the bill in section 1, in that part designated "§701." by striking out all of subsection 3 and inserting in its place the following:

"Average final compensation" means the average annual rate of earnable compensation of a member during the 3 years of creditable service, not necessarily consecutive, as a Legislator in which the average annual rate of earnable compensation is highest or during his entire period of creditable service if the period is less than 3 years.'
21 22 23 24 25	Further amend the bill in section 1, in that part designated "§801." in subsection 1, in the 15th line (page 9, line 9 in L.D.) by striking out the underlined word "may" and inserting in its place the following: 'shall'
26 27 28 29 30 31 32 33	Further amend the bill in section 1, in that part designated "§851." in subsection 2, in the 3rd line (page 13, line 20 in L.D.) by inserting after the following: "birthday." the following: 'Creditable service as a member of the Maine State Retirement System after service as a member of the Maine Legislative Retirement System shall be used in determining the completion of 25 years of creditable service.'
34 35	Further amend the bill by striking out all of section 4 and inserting in its place the following:
36 37	'Sec. 4. 5 MRSA §1121, sub-§3, as amended by PL 1973, c. 542, §8, is further amended to read:

For this purpose the tables of annuities as approved by the board of trustees at the date of retirement shall be used.'

23 24 25 26	This amendment provides a mechanism for computing retirement benefits for legislative service separate from the retirement benefits associated with state service.
