9 10 11 12 13 14 15 16 17	The purpose of this new draft is to have the fees charged by municipalities and municipal clerks for birth, marriage or death records more accurately reflect the costs incurred in searching for and providing the records. The fee for providing a certified copy of a birth, marriage or death record is raised from \$2 to \$5. The fee for additional certified copies issued at the same time remains at \$2 apiece since little additional work or time is required to provide these copies.
