HOUSE AMENDMENT "A" to COMMITTEE AMENDMENT "A"
to H.P. 854, L.D. 1210, Bill, "AN ACT Concerning Re-
ports to the Federal Government Relating to Missing
Children."

Amend the Amendment by inserting after the title
the following:

'Amend the Bill by inserting after the enacting
clause the following:

Sec. 1. 25 MRSA §1508 is enacted to read:
§1508. Law enforcement telecommunications system

The Bureau of the State Police shall provide for
the installation, operation and maintenance of a law
enforcement telecommunications system for the purpose
of promptly collecting, exchanging and distributing
information relating to police problems of the State,
counties, cities and towns. The system may be con-
nected, directly or indirectly, with similar systems
operated and maintained by other states or the Feder-
al Government.

The Chief of the State Police shall provide for
the location and maintenance of the central process-
ing system and lines. The state departments and
agencies, counties, cities and towns shall provide,
at their own expense, the terminals and modems, and
for the personnel and supplies, for their proper op-
erations.

The system shall be installed, operated and main-
tained in accordance with the rules adopted by the
National Law Enforcement Telecommunications System,
the National Crime Information Center and the Chief

1 of the State Police or his designee. The character
2 of the communications sent, the time, place and man-
3 ner of sending messages and all matters connected
4 with the system shall be under the control and man-
5 agement of the Chief of the State Police or his des-
6 ignee.'

7 Further amend the Bill by inserting at the begin-
8 ning of the first line after the enacting clause (
9 page 1, line 23 in L.D.) the following: 'Sec. 2.'

10 Further amend the Amendment in the first line af-
11 ter the title by striking out the word "Amend" and
12 inserting in its place the words 'Further amend'

13 STATEMENT OF FACT

14 The purpose of this amendment is to allow the
15 State to comply with the National Crime Information
16 Center and the National Law Enforcement Telecommuni-
17 cations System user agreements and to provide for
18 uniformity within the State Law Enforcement Telecom-
19 munications System.
