STATEMENT OF FACT

This amendment reduces and changes the prize structure of the program. It specifies supersport license fees as the source of funding for the program. It excludes department employees from participation. It provides for a 2-year sunset. It funds the bill for 2 years but does not change the total amount allocated. Instead, it merely extends the funding in the original bill over the 2-year period.
