Amend the bill in section 1 in that part designat-
ed "§7521." in subsection 1 in paragraph A (page
2, line 1 in L.D.) by striking out the following:
"\$3,000" and inserting in its place the following:
'\$1,500'

Further amend the bill in section 1 in that part
designated "§7521." in subsection 1 in paragraph C
(page 2, line 3 in L.D.) by striking out the follow-
ing: "\$3,000" and inserting in its place the follow-
ing: '\$500'

Further amend the bill in section 1 in that part
designated "§7521." in subsection 1 in paragraph D
(page 2, line 4 in L.D.) by striking out the follow-
ing: "\$1,000; and" and inserting in its place the
following: '\$500;'

Further amend the bill in section 1 in that part
designated "§7521." in subsection 1 in paragraph E
(page 2, line 5 in L.D.) by striking out the follow-
ing: "\$2,000." and inserting in its place the follow-
ing: '\$1,000; and'

Further amend the bill in section 1 in that part
designated "§7521." in subsection 1 by inserting af-
ter paragraph E the following:

'F. Drawing\$500.'

Further amend the bill in section 1 in that part
designated "§7521." in subsection 2 in the 2nd line
(page 2, line 7 in L.D.) by striking out the under-

1 lined words "Coyote Award Fund" and inserting in
2 their place the following: 'funds derived from the
3 sale of the supersport license'

4 Further amend the bill in section 1 in that part
5 designated "§7521." in subsection 2 in the 5th and
6 6th lines (page 2, lines 10 and 11 in L.D.) by strik-
7 ing out the following: "D and E." and inserting in
8 its place the following: 'D, E and F.'

9 Further amend the bill in section 1 in that part
10 designated "§7521." by inserting after subsection 3
11 the following:

12 '4. Eligibility. Employees of the department,
13 including part-time and seasonal, and agents of the
14 Animal Damage Control Program, including those who
15 are not compensated, are not eligible to participate
16 in any aspect of this program.

17 '5. Repeal. This Act is repealed on September
18 30, 1986.'

19 Further amend the bill by striking out all of
20 section 2 and inserting in its place the following:

21 'Sec. 2. Allocation. The following funds are
22 allocated from the Department of Inland Fisheries and
23 Wildlife to carry out the purposes of this Act.

2 STATEMENT OF FACT

3 This committee of conference amendment incorpo-
4 rates all of the changes proposed in committee amend-
5 ment A, except that the sunset provision takes effect
6 September 30, 1986, rather than 1987 and, according-
7 ly, one fiscal year allocation is removed. This com-
8 mittee of conference amendment further sets out Octo-
9 ber 1, 1985, as the effective date rather than making
10 the effective date 90 days after the adjournment of
11 the Legislature.
