SENATE AMENDMENT "C" to S.P. 493, L.D. 1319,  
Bill, "AN ACT to Amend Certain Sections of the Em-  
ployment Security Law."

Amend the Bill in section 2, in subsection 19,  
paragraph B, subparagraph (1), division (b), in the  
3rd line (page 3, line 25 in L.D.) by adding after  
the underlined word and punctuation "disability;" the  
underlined word 'or'

Further amend the Bill in section 2, in subsec-  
tion 19, paragraph B, subparagraph (1), by striking  
out all of divisions (c) and (d), (page 3, lines 26  
to 35 in L.D.) and inserting in their place the fol-  
lowing:

(c) Death;

(1-A) Any payment on account of sickness or  
accident disability, or medical or hospital-  
ization expenses in connection with sickness  
or accident disability, made by an employer  
to, or on behalf of, an employee after the  
expiration of 6 calendar months following  
the last calendar month in which the employ-  
ee worked for that employer;

Further amend the bill in section 2, in subsec-  
tion 19, paragraph B, subparagraph (2), in the last  
line (page 4, line 4 in L.D.) by inserting after the  
words and punctuation "labor;" the underlined word  
'or'

Further amend the Bill in section 2, in subsec-  
tion 19, in paragraph B, in subparagraph (3), in the  
last line (page 4, line 12 in L.D.) by striking out  
the underlined word "and"

1 Further amend the Bill in section 2, in subsec-  
2 tion 19, in paragraph C, in the last line (page 5,  
3 line 2 in L.D.) by striking out the following: "ser-  
4 vices." and inserting in its place the following:  
5 '~~services-~~ services; and'

6 Further amend the Bill in section 2 in subsection  
7 19 by adding at the end the following:


8 'D. Nothing in this subsection may be construed  
9 to include as wages any payment which is not in-  
10 cluded as wages under the Federal Unemployment  
11 Tax Act, 26 United States Code, Section  
12 3306(b)(5) and (r), as amended, as of January 1,  
13 1985.'
