HOUSE AMENDMENT "A" to COMMITTEE AMENDMENT "A"  
to H.P. 951, L.D. 1370, Bill, "AN ACT to Expand and  
Continue Alcoholism Treatment, Education, Prevention  
and Research Programs."

Amend the amendment by inserting after the title  
the following:

'Amend the bill by inserting after the enacting  
clause the following:

Sec. 1. 3 MRSA §507-C is enacted to read:

§507-C. Other state programs

1. Report required. A justification report  
shall be prepared and submitted to the Legislature  
for the following programs:

A. Alcoholism Prevention, Education Treatment  
and Research Fund. Each of the following agencies  
shall be responsible for reporting on its por-  
tion of the program:

- (1) Department of Education and Cultural  
Services;
- (2) Department of Human Services;
- (3) Department of Mental Health and Mental  
Retardation; and
- (4) Department of Corrections.

If, after submitting its first qualification report,  
any program set forth in this section has not been  
terminated by this section or any other Act of the

1 Legislature, it shall prepare and submit to the Leg-  
2 islature a justification report, pursuant this sec-  
3 tion, at least once every 5 years.

4 2. Contents of justification reports. Each re-  
5 port shall be as set out in section 504, subsection  
6 2.

7 3. Submittal of justification reports. Any pro-  
8 gram set forth in this section shall submit its jus-  
9 tification reports to the Legislature through the  
10 Legislative Administrative Director, by January 31,  
11 1987.

12 4. Termination dates. Unless continued or modi-  
13 fied by law, the following programs shall terminate,  
14 not including the grace period, on the following  
15 dates:

16 A. Alcoholism Prevention, Education, Treatment  
17 and Research Fund shall terminate on July 1,  
18 1987.

19 Further amend the bill by inserting at the begin-  
20 ning of the first line after the enacting clause the  
21 following: 'Sec. 2.'

22 Further amend the amendment by striking out at  
23 the beginning of the first line after the title the  
24 following: "Amend" and inserting in its place the  
25 following: 'Further amend'
