Amend the amendment by inserting after the title

the following:

'Amend the bill in the first line after the en-

acting clause (page 1, line 23 in L.D.), by inserting

at the beginning the following: 'Sec. 1.' '

Further amend the amendment in the first para-

graph after the title in the first line (page 1, line

11 in amendment), by striking out the word "Amend"

and inserting in its place the words 'Further amend'

Further amend the amendment by adding after the

21

first paragraph after the title the following:

'Further amend the bill by inserting after the

2nd paragraph after the enacting clause, the follow-

ing:

'Sec. 2. 28 MRSA §472, sub-§2, as enacted by PL

1981, c. 454, §8, is repealed and the following en-

acted in its place:

10 the end before the statement of fact (page 1, line 25
11 in amendment) by striking out the figure "2,400,000"
12 and inserting in its place the figure '2,600,000'

13 Further amend the amendment in the last line be-
14 fore the statement of fact (page 1, line 26 in amend-
15 ment) by striking out the symbols and figure
16 "(\$600,000)" and inserting in their place the symbol
17 and figure '\$1,800,000'

18 Further amend the amendment by inserting at the
19 end, before the statement of fact the following:

20 'Further amend the bill by renumbering the sec-
21 tions to read consecutively.'
