14The director shall submit to the Governor, not15later than January 15th of each year, a complete16report on activities relating to the Job Develop-17ment Training Fund, as it relates to the shoe18manufacturing industry, including an audited ac-19counting of its receipts and expenditures, assets20and liabilities, at the end of its fiscal year.

21The Legislature shall make annual appropriations22to the State Development Office to be used for23the purposes of this paragraph relating to the24shoe manufacturing insutry. Funds expended shall25not lapse but shall be carried forward.

STATEMENT OF FACT

The purpose of this bill is to provide that job development funds shall be used to train or retrain labor for new or expanding businesses engaged in shoe manufacturing.
