The purpose of the public hearing shall be to explain the contents of the plan or program proposed for adoption or amendment and to elicit public comments from the residents of the planning area on the proposal. All comments received shall be considered. The public hearing shall be held in the evening at a convenient time and place. At least 10 days prior to the public hearing, notice shall be published in newspapers of general circulation in this State.'

30 31 32 33 34	Further amend the bill in section 4, in the first paragraph after the amending clause, in the 8th line (page 3, line 8 in L.D.) by inserting after the underlined word "comments" the following: 'from the residents of the planning area'
35 36 37 38	Further amend the bill in section 4, in the 2nd paragraph after the amending clause, in the first line (page 3, line 14 in L.D.) by striking out the underlined figure "20" and inserting in its place the

10 11 12 13 14 15	This amendment makes it clear that the requirement of public hearings is prospective only and that the public hearings will elicit public comment only from the residents of the planning area. The amendment also reduces the public notice requirement to one notice 10 days before the hearing.
