The biennial fee for 29 a journeyman plumber's license shall be \$30.' 30 Further amend the bill in section 37, by striking 31 out all of subsection 5 (page 20, lines 1 to 11 in L.D.) and inserting in its place the following: 32 '5. 13 Any person ordered by the board to cease and de-14 sist may appeal to the Superior Court in accordance 15 with the Maine Administrative Procedure Act, Title 5, 16 chapter 375, subchapter VII, by filing a petition for The 17 review within 48 hours of receipt of the order. 18 court shall issue a written decision within 20 days after receipt of the petition for review. The deci-19 sion of the Superior Court on an appeal as provided 20 is final. The decision of the board or order of the board shall also be final and subject to no further appeal upon failure to file a timely written appeal 21 22 23 24 as provided.
