HOUSE AMENDMENT "A" to H.P. 1103, L.D. 1611,
"Resolve, Authorizing the Somerset County Commission-
ers to Expend \$130,000 from Revenue Generated Through
the Boarding of Prisoners for the Purpose of Making
Modifications to the Somerset County Jail to Increase
the Jails Rated Capacity."

Amend the resolve by striking out all of the ti-
tle and inserting in its place the following:

'Resolve, Authorizing the Somerset County Commis-
sioners to Expend \$130,000 from the General Fund for
the Purpose of Making Modifications to the Somers-
et County Jail to Increase the Jails Rated Capacity.'

Further amend the resolve in the 2nd paragraph
after the title, in the 1st and 2nd lines (page 1,
lines 31 and 32 in L.D.) by striking out the follow-
ing: "fiscal year 1985-86" and inserting in its
place the following: 'calendar year 1985'

Further amend the resolve by striking out all of
the 2nd paragraph from the end before the statement
of fact (page 2, lines 10 to 16 in L.D.) and insert-
ing in their place the following:

'Authorization; expenditure for jail modifica-
tion. Resolved: That notwithstanding the Maine Re-
vised Statutes, Title 30, section 404, the Somerset
County Commissioners are authorized to expend a sum
not to exceed \$130,000 from the General Fund in the
year 1986 to make necessary modifications to the
Somerset County jail to increase the jails rated in-
mate capacity; and be it further

Resolved: That any preliminary expenses incurred
in 1985 may be paid from the contingent account.'
