SENATE AMENDMENT "A" to H.P. 1125, L.D. 1631,
Bill, "AN ACT Regarding Members of the Public Serving
on State Licensing Boards."

Amend the Bill by inserting after section 1 the
following:

'Sec. 2. 32 MRSA §271, 2nd ¶, as amended by PL
1983, c. 812, §195, is further amended to read:

The board shall be composed of 3 5 members, 2 3
of whom shall be auctioneers and ~~one 2~~ of whom shall
be a public ~~member~~ members. Members shall be ap-
pointed by the commissioner and shall be compensated
according to the provisions of Title 5, chapter 375.

Sec. 3. 32 MRSA §3401, as amended by PL 1983, c.
812, §229, is further amended to read:

§3401. Membership; vacancies; removal; compensation

A Plumbers' Examining Board, as established by
Title 5, section 12004, subsection 1, shall consist
of 3 5 members, who shall be appointed by the Govern-
nor. ~~One Two~~ of the members shall be a
representative representatives of the public, ~~one 2~~
shall be a master ~~plumber~~ plumbers as defined in sec-
tion 3301, and one shall be a journeyman plumber as
defined in section 3301, and who has been engaged in
the business of plumbing for at least 2 years. Mem-
bers shall be appointed for terms of 2 years, with no
person being eligible to serve more than 4 full con-
secutive terms, provided that for this purpose only a
period actually served which exceeds 1/2 of the
2-year term shall be deemed a full term. Upon expi-
ration of a member's term, he shall serve until his
successor is qualified and appointed. The

1 successor's terms shall be 2 years from the date of
2 the expiration, regardless of the date of his ap-
3 pointment. Any vacancy in the board caused by
4 death, resignation or removal of any member shall be
5 filled by the appointment of a person qualified, to
6 hold office during the unexpired term of the member
7 whose place is thus filled. Any member of the board
8 may be removed from office for cause, by the Gover-
9 nor. The members of the board shall each be compen-
10 sated according to the provisions of Title 5, chapter
11 379. The board may examine and license plumbers.'

12 Further amend the Bill by striking out all of
13 section 2

14 STATEMENT OF FACT

15 The Plumbers' Examining Board is increased to 5
16 members so that the 2 public members will not consti-
17 tute a majority on the board.

18 The amendment also increases the membership of
19 the Auctioneers Advisory Board from 3 to 5 years.

20 The amendment removes the section of bill requir-
21 ing a board report to the Legislature.
