STATEMENT OF FACT

13 This amendment makes technical changes to the 14 bill to provide that appropriations, equipment, prop-15 erty and funds of the vocational-technical institutes are transferred to the Maine Vocational-technical In-16 17 stitutes Administration. This amendment also corrects the appropriations section, but does not change the total figures in order to reflect the changes at each 18 19 20 institute.

This amendment removes section 1 of the bill which establishes the pay range for the Executive Director of the Maine Vocational-technical Institutes Administration with other state agency officials. Since the executive director is not a state employee, the pay range cannot be established in the laws relating to the state officials.
