STATEMENT OF FACT

11 This amendment provides that the directors of 12 each institute, who are appointed by the 13 commissioner, shall serve at the pleasure of the 14 board which is the policy-making authority and has 15 administrative oversight over the institute. The di-16 rectors of the institutes are authorized to employ 17 assistant directors who serve at the pleasure of the 18 directors.

19 In addition, this amendment provides that the di-20 rectors have responsibility for the day-to-day opera-21 tion of the institutes under the direction of the 22 commissioner.
