SENATE AMENDMENT " B " to HOUSE AMENDMENT "B" to
8 S.P. 628, L.D. 1645, Bill, "AN ACT Relating to the
9 Administration of Vocational Education."

10

Amend the amendment in section 5 by striking out
11 all of that part designated "§12551." and inserting
12 in its place the following:

13

'§12551. Purpose and intent

14

1. Purpose. The purpose of this chapter is to:

15

A. Create vocational-technical institutes in
16 Maine which will be able to respond to the needs
17 of the people of the State for vocational, tech-
18 nical and occupational training; and

19

B. Provide for responsive administration of the
20 vocational-technical institutes.

21

2. Intent. It is the intent of the Legislature
22 that the vocational-technical institutes shall:

23

A. Provide vocational, technical and occupation-
24 al education for those who demonstrate aptitude
25 and need and who require training designed for
26 service in agriculture, trade, industry or com-
27 merce;

28

B. Provide each graduate with job skills;

29

C. Provide the general education necessary to
30 complement the requirements of specific vocation-
31 al and technical skills;

D. Provide supplementary educational programs to
33 upgrade those persons already employed or retrain

2 E. Provide special programs for disadvantaged
3 and handicapped persons to permit them to take

8 tion 4 the following:

9 '5. Vocational-technical institute system.
10 "Vocational-technical institute system" means the
11 combined entity of all vocational-technical insti-
12 tutes.

13 6. Vocational-technical institute fund.
14 "Vocational-technical institute fund" is the fund es-
15 tablished under section 12561-A.'

16 Further amend the amendment in section 5 in that
17 part designated "§12554." in subsection 3 in the 3rd
18 line (page 7, line 31 in amendment) by striking out
19 the underlined word "institutes" and inserting in its
20 place the following: 'institute system'

21 Further amend the amendment in section 5 in that

23 tion 4 the following:

24 '5. Enter into contracts and agreements. Enter
25 into any contracts, leases and agreements and all
26 other instruments and arrangements that are neces-
27 sary, incidental or convenient to the performance of
28 its duties and the execution of its powers under this
29 chapter;

30 6. Acquire property by purchase, lease or rent.
31 Acquire by purchase, lease or rent any lands, build-
32 ings, structures, facilities or equipment to further
33 the purposes of this chapter;

1 7. Sell and dispose of property. Sell and dis-
2 pose of property, including lands, buildings, struc-

7 8. Undertake construction and renovation. Ap-
8 prove the construction, renovation and reconstruction
9 of buildings, structures and facilities within the
10 constraints of the budget of the vocational-technical
11 institute system;

13 part designated "§12554." in subsection 6 in the
14 first 4 lines (page 8, lines 16 to 19 in amendment)
15 by striking out the following: "Establish and oversee
16 the operation of the vocational-technical institutes.

19 its place the following: 'Establish and promote spe-
20 cialized training. Establish and'

24 '7. Establish and collect program fees and
25 charges. Establish and collect program fees, tuition
26 and other charges as necessary for the efficient im-
27 plementation of this chapter to be deposited in the
28 vocational-technical institute fund and used accord-
29 ing to section 12551;

30 8. Establish and collect use fees. Establish
31 and collect reasonable fees for the use of the insti-
32 tutes' facilities by others. These fees shall be re-
33 tained by the institute which incurs the costs;

8 the following: "commissioner;" and inserting in its
9 place the following: 'commissioner and approve the
10 director's appointment of the assistant director who
11 shall serve at the pleasure of the director;'

12 Further amend the amendment in section 5 in that
13 part designated "§12554." by inserting after subsec-
14 tion 8 the following:

15 '9. Adopt and approve personnel policies. Adopt
16 and approve personnel policies and procedures for the
17 vocational-technical institutes. The board shall
18 recommend the qualifications, duties and compensation
19 of its employees. These provisions shall be consist-
20 ent with any collective bargaining acts and agree-
21 ments;'

25 '10. Work with private sector. Work closely
26 with the private sector in order to insure that the
27 vocational-technical institutes respond expeditiously
28 to the needs of the private sector and the state

30 nology, industries and job needs;

31 '11. Expend, allocate and transfer funds. Expend
32 funds as necessary to fulfill this chapter and allo-
33 cate and transfer funds within the
34 vocational-technical institute system under the ad-
35 ministration of the board and the commissioner as the
36 board deems necessary;

11 part of an adult education program, they shall be ad-
12 ministered as satellite programs of an institute des-
13 ignated by the state board.

14 3. Tuition. Tuition for these courses shall be
15 charged directly to the students enrolled, at rates
16 approved by the state board.'

17 Further amend the amendment in section 5 by in-
18 serting after that part designated "§12561." the fol-
19 lowing:

20 '§12561-A. Nonlapsing revolving fund

21 A nonlapsing, interest earning, revolving fund,
22 known as the vocational-technical institute fund, is
23 created to implement this chapter. Any unexpended
24 balance of funds appropriated by the Legislature to
25 the vocational-technical institute system shall be
26 carried over for the continued use in the programs
27 within the system. The fund may also receive, invest
28 and expend money from gifts, grants, bequests, dona-
29 tions, program fees, tuition, other charges and the
30 sale and disposal of property in accordance with sec-
31 tion 12554, subsection 4.'

10 Institutes staff needs to carry out its duties out-
11 lined in this Act;

12 2. Vocational-technical institute staff and ad-
13 ministrative needs. The staff and administrative
14 needs of the vocational-technical institutes to carry
15 out the intent of this Act and the original purpose
16 in establishing the vocational-technical institutes
17 of providing "responsive administration;"

18 3. Department of Personnel and Department of Fi-
19 nance and Administration. The policies and proce-
20 dures of the Department of Personnel and the Depart-
21 ment of Finance and Administration as they relate to
22 the provision of vocational education to meet the
23 needs of Maine's industry and labor force;

24 4. Collective bargaining. The State's role with
25 respect to the collective bargaining units within the
26 vocational-technical institute system;

27 5. Appropriation. The appropriation of lump-sum
28 appropriations for the vocational-technical insti-
29 tutes;

30 6. Labor negotiations. To conduct labor negoti-
31 ations within the vocational-technical institute sys-
32 tem;

33 7. Personnel decisions. To have flexibility in
34 personnel employment and management decisions in the

22 This amendment amends the House amendment by
23 first replacing the statement of purpose and mission
24 with the purpose and intent section in present law.

25 It further inserts sections in the Joint Standing
26 Committee on Education's original bill which were
27 left out of the house amendment.

28 Finally, it inserts one section from present law
29 on courses at secondary vocational facilities which
30 was omitted from the house amendment and adds a
31 deappropriation to the bill.


