22 23 24	Emergency preamble. Whereas, Acts of the Legis- lature do not become effective until 90 days after adjournment unless enacted as emergencies; and					
25 26	Whereas, the 90-day period will not terminate un- til after the beginning of the next fiscal year; and					
27 28 29 30	Whereas, certain obligations and expenses inci- dent to the operation of state collective bargaining agreements will become due and payable immediately; and					
31 32 33 34	Whereas, it is the responsibility of the Legisla- ture to act upon those portions of tentative collec- tive bargaining agreements negotiated by the Execu- tive Branch which require legislative action; and					

1 Whereas, in the judgment of the Legislature, 2 these facts create an emergency within the meaning of 3 the Constitution of Maine and require the following 4 legislation as immediately necessary for the preser-5 vation of the public peace, health and safety; now, 6 therefore,

7 Be it enacted by the People of the State of Maine as 8 follows:

PART A

10 Sec. 1. Allocation from the Special Compensation 11 Account. There is allocated from the Special Compensation Account the sum of \$29,692 for the fiscal year 12 13 ending June 30, 1986, and the sum of \$30,286 for the 14 fiscal year ending June 30, 1987, to implement the 15 economic terms in the collective bargaining agreement 16 agreed to by the State Board of Education and the 17 Vocational-technical Institute Administrators Bar-18 gaining Unit.

19 Sec. 2. Special account funding. Funding provided by this Act shall be segregated into a special 20 21 account to be made available as needed with the rec-22 ommendation of the State Budget Officer, with the apof the Governor. The funds shall include re-23 proval 24 tirement costs. Positions supported from sources of 25 funding other than the General Fund shall be funded 26 whenever possible from those other sources.

27 Sec. 3. Adjustment of salary schedule. Effective 28 the pay week closest to July 1, 1985, the salary 29 schedule for employees in the Vocational-technical 30 Institute Administrators Bargaining Unit shall be ad-31 justed by 3 1/2% consistent with the terms of the 32 collective bargaining agreement.

33 Sec. 4. Adjustment of salary schedule. Effective 34 the pay week closest to January 1, 1986, the salary 35 schedule for employees in the Vocational-technical 36 Institute Administrators Bargaining Unit shall be ad-37 justed by 1 1/2% consistent with the terms of the 38 collective bargaining agreement.

1 Sec. 5. New employees, similar and equitable treatment. Employees in classifications included in 2 the Vocational-technical Institute Administrators 3 Bargaining Unit, but who are excluded from collective 4 bargaining pursuant to the Maine Revised Statutes, 5 Title 26, section 1022, subsection 11, paragraph D, 6 7 shall be given similar and equitable treatment on a pro rata basis to that given employees covered by the 8 9 contract.

PART B

Carrying clause. Any balances remaining in spe cial compensation accounts shall not lapse, but shall
 be carried forward to June 30, 1987.

14 Emergency clause. In view of the emergency cited 15 in the preamble, this Act shall take effect when ap-16 proved.

17 FISCAL NOTE

18 This bill provides funding and implementation for 19 the economic items in the collective bargaining 20 agreement reached between the State Board of Educa-21 tion and the Vocational-technical Institute Adminis-22 trators Bargaining Unit for the fiscal years speci-23 fied.

32 Part A of this bill provides funding and imple-33 mentation of the economic items in the collective 34 bargaining agreement reached between the State Board

- of Education and the Vocational-technical Institute
   Administrators Bargaining Unit for fiscal year 1986
   and fiscal year 1987.
- 4 Section 1 provides an allocation to fund the col-5 lective bargaining agreement.
- 6 Section 2 provides an authorization for the ap-7 proval and use of funds.

8 Section 3 provides for the adjustment of salary 9 schedules by an increase of 3 1/2% effective the pay 10 week closest to July 1, 1985, for bargaining unit 11 members.

Section 4 provides for the adjustment of the then current salary schedules by an increase of 1 1/2% effective the pay week closest to January 1, 1986, for bargaining unit members.

Section 5 provides for the equitable treatment of probationary and other employees in classification within the Vocational-technical Institute Administrators Bargaining Unit.

20 Part B of this bill provides for any unspent 21 funds to carry forward until June 30, 1987.
