4th lines (page 4, lines 13 and 14 in L.D.) by strik-  
ing out the following: ", Parts A and B,"

is further amended to read:

§1511. Reserve for General Fund Operating Capital

The State Controller is authorized, at the close  
of each fiscal year, to transfer from the Unappropri-  
ated Surplus of the General Fund to the Reserve for  
General Fund Operating Capital such amounts as may be  
available from time to time up to an amount of  
\$1,000,000 per year until a maximum of \$25,000,000  
shall be achieved. Further, the State Controller is  
authorized, at the close of each fiscal year, to  
transfer from the General Fund to the Guarantee Re-  
serve Fund such additional amounts as may be availa-  
ble from time to time up to an amount of \$1,000,000  
per year until a maximum of \$10,000,000 is achieved

12 STATEMENT OF FACT

13 This amendment removes the Parts that address  
14 the Maine State Troopers Bargaining Unit. The Maine  
15 State Troopers Bargaining Unit has not ratified the  
16 agreement. Part D increases the amount of Unappropri-  
17 ated Surplus of the General Fund that may be trans-  
18 ferred to the Guarantee Reserve Fund from \$1,000,000  
19 to \$2,000,000 for state fiscal years 1986, 1987 and  
20 1988.
