Further amend the Bill in PART D in the 3rd and 4th lines (page 4, lines 13 and 14 in L.D.) by striking out the following: ", Parts A and B,"

5 MRSA §1511, as amended by PL 1981, c. 192, §1, is further amended to read:
§1511. Reserve for General Fund Operating Capital
The State Controller is authorized, at the close of each fiscal year, to transfer from the Unappropriated Surplus of the General Fund to the Reserve for General Fund Operating Capital such amounts as may be available from time to time up to an amount of \$1,000,000 per year until a maximum of \$25,000,000 shall be achieved. Further, the State Controller is authorized, at the close of each fiscal year, to transfer from the General Fund to the Guarantee Reserve Fund such additional amounts as may be available from time to time up to an amount of \$1,000,000 per year until a maximum of \$10,000,000 is achieved

Part D increases the amount of Unappropriated Surplus of the General Fund that may be transferred to the Guarantee Reserve Fund from \$1,000,000 to \$2,000,000 for state fiscal years 1986, 1987 and 1988.
