18 Resolve, Authorizing Kennebec County to Pay  
19 Deficits from Unappropriated Surplus.

21 Emergency preamble. Whereas, Acts and resolves  
22 of the Legislature do not become effective until 90  
23 days after adjournment unless enacted as emergencies;  
24 and

25 Whereas, the unforeseen jail personnel costs for  
26 Kennebec County forced Kennebec County to make addi-  
27 tional expenditures in the jail budget; and

28 Whereas, the population of prisoners in Kennebec  
29 County has increased; and

30 Whereas, these expenses could not have been  
31 foreseen in the original Kennebec County budget but  
32 must now be met as soon as possible; and

33 Whereas, in the judgment of the Legislature,  
34 these facts create an emergency within the meaning of

1 the Constitution of Maine and require the following  
2 legislation as immediately necessary for the preser-  
3 vation of the public peace, health and safety; now,  
4 therefore, be it

5 Kennebec County Commissioners; reimbursement for  
6 overdrafts authorized. Resolved: That the Kennebec  
7 County Commissioners are authorized to expend from  
8 the Kennebec County surplus account the sum of  
9 \$30,000 to meet overdrafts in the following jail de-  
10 partment (1050) accounts:

11 Account # 3000 \$30,000

12 Emergency clause. In view of the emergency  
13 cited in the preamble, this Resolve shall take effect  
14 when approved.

15 STATEMENT OF FACT

16 The purpose of this resolve is to permit Kenne-  
17 bec County to pay deficits in the jail budget from  
18 unappropriated surplus.
