18 AN ACT to Permit the Northern Maine General
19 Hospital of Eagle Lake to Maintain a

22 **Emergency preamble.** Whereas, Acts of the Legis-
23 lature do not become effective until 90 days after
24 adjournment unless enacted as emergencies; and

25 Whereas, the trustees of the Northern Maine Gen-
26 eral Hospital of Eagle Lake have determined that a
27 juvenile home should be constructed and maintained to
28 better serve that area of the State; and

29 Whereas, this legislation is vitally necessary in
30 order to clarify the hospital's authority to estab-
31 lish the home, so that financing needs can be prop-
32 erly met; and

33 Whereas, in the judgment of the Legislature,
34 these facts create an emergency within the meaning of

1 the Constitution of Maine and require the following
2 legislation as immediately necessary for the preser-
3 vation of the public peace, health and safety; now,
4 therefore,

5 Be it enacted by the People of the State of Maine as
6 follows:

7 P&SL 1907, c. 84, §6-E is enacted to read:

8 6-E. Juvenile home. The corporation may estab-
9 lish and maintain a juvenile home to be known as the
10 Philip Blanchette Youth Home. For the purpose of
11 this section, the corporation shall maintain a sepa-
12 rate division of finance for the home, to administer
13 matters of income, assets, liabilities and other mat-
14 ters of finance.

15 Emergency clause. In view of the emergency cited
16 in the preamble, this Act shall take effect when ap-
17 proved.

18 STATEMENT OF FACT

19 The purpose of this bill is to permit the North-
20 ern Maine General Hospital of Eagle Lake to maintain
21 a juvenile home.
