19 20 21	Further amend the bill by inserting after the enacting clause and before the amending clause (page 1, line 22 in L.D.) the following: 'Sec. 2.'
22 23 24 25	Further amend the bill in that part designated "§1." by striking out all of the last sentence (page 2, lines 4 and 5 in L.D.) and inserting in its place the following:
26 27 28 29 30	'The municipal officers may prohibit a harbor master from making arrests or carrying a weapon. Any law enforcement officer vested with the authority to carry a weapon and make arrests shall have the authority to enforce the provisions of this subchapter.

STATEMENT OF FACT

The purpose of this amendment is to authorize 6 cities as well as towns to limit the authority of 7 harbor masters and not empower harbor masters to make arrests or carry a weapon. Any other law enforcement officer vested with the authority to carry a weapon and make arrests is empowered to enforce the law dealing with harbor masters. 8 9
