Whereas, Acts of the Legislature do not become effective until 90 days after 12 13 adjournment unless enacted as emergencies; and 14 Whereas, the production of blueberry and apple 15 crops depends upon pollination by honeybees; and Whereas, the ability of honeybees to pollinate the blueberry and apple crops is dependent upon 16 17 healthy bees making a timely migration into the 18 19 State; and 20 Whereas, diseases may be spread from honeybees of 21 migratory beekeepers to those owned by commercial and 22 hobby residential beekeepers; and 23 Whereas, the Department of Agriculture, Food and 24 Rural Resources is responsible for enforcement of the 25 apiary laws to ensure that only healthy honeybees en-26 ter the State; and 27 Whereas, the Department of Agriculture, Food and Rural Resources requests these changes to strengthen 28 29 enforcement capabilities; and 30 Whereas, in the judgment of the Legislature, 31 these facts create an emergency within the meaning of 32 the Constitution of Maine and require the following legislation as immediately necessary for the preser-vation of the public peace, health and safety; now, 33 34 therefore, ' 35

1 2 COMMITTEE AMENDMENT "A" to H.P. 1223, L.D. 1730

1 Further amend the bill in that part designated 2 "<u>§2771.</u>" in the 12th line (page 4, line 14 in L.D.) 3 by striking out the underlined words "or infected" 4 and inserting in their place the following: <u>or</u> 5 infested'

6 Further amend the bill in that part designated 7 "<u>§2852.</u>" in the 2nd line (page 6, line 12 in L.D.) by 8 inserting after the underlined word "<u>beekeeper</u>" the 9 following underlined words '<u>or his designee</u>'

10 Further amend the bill by inserting before the 11 Statement of Fact the following:

12 'Emergency clause. In view of the emergency cited 13 in the preamble, this Act shall take effect when ap-14 proved.'
