12	Amend the bill in section 2 in that part designated "Sec. 11." in the last line (page 7, line 33 in L.D.) by striking out the following: ', section 3311'
L4 L5	Further amend the bill by striking out all of the emergency clause (page 8, lines 19 to 21 in L.D.) and
16	inserting in its place the following:
١7	'Emergency clause; referendum. In view of the
18	emergency cited in the preamble, this Act shall take
19	effect when approved for the sole purpose of permit-
20	ting its submission to the legal voters within the
21	Freeport Sewer District at an election to be called
22	for that purpose and to be held prior to December 31,
23	1987. The election shall be called, advertised and
24	conducted according to the law relating to municipal
25	elections, provided that the registrar of voters in
26	the municipality shall not be required to prepare or
27	the clerk to post a new list of voters, and for this
28	purpose the registrar of voters shall be in session
29	the 3 secular days preceding the election, of which
30	the first 2 days will be devoted to registration of
31	the voters and the last day to enable the registrars
32	to verify the lists and to complete the records of
33	these sessions. The subject matter of this Act shall
34	be reduced to the following question.

3 4 5 6	The results shall be declared by the municipal officers of the Town of Freeport and due certificate thereof filed by the clerk with the Secretary of State.
7 8 9 10 11 12	This Act shall take effect for all its purposes immediately upon its acceptance by a majority of all legal voters in the Freeport Sewer District voting at the special election. Failure of the approval by the necessary majority of voters at any such election shall not prevent a subsequent election to be held for that purpose.'
14	STATEMENT OF FACT
15 16 17 18	The amendment makes a technical change and adds a local referendum to the bill. The bill authorizes the Freeport Sewer District to acquire the Freeport Branch of the Maine Water Company.
