7 COMMITTEE AMENDMENT " \mathcal{H} " to H.P. 1560, L.D. 8 2199, Bill, "AN ACT to Establish the Maine Workers' 9 Compensation Reinsurance Association."

10 Amend the bill by striking out all of the title 11 and inserting in its place the following:

12 'AN ACT to Establish the Workers' Compensation Reinsurance Study Commission.'

14 Further amend the bill by striking out everything 15 after the enacting clause and inserting in its place 16 the following:

17 'Sec. 1. Commission established. There is established the Workers' Compensation Reinsurance Study 18 19 Commission. The 5 members of the commission shall be 20 appointed jointly by the President of the Senate and 21 the Speaker of the House of Representatives as follows: One member shall be an employer; one member 22 shall be an employee; one member shall represent in-23 24 surers; one member shall represent self-insurers; and 25 one member shall represent the public. Members shall 26 receive compensation for per diem and expenses.

27 The commission shall Sec. 2. Scope of study. identify and enumerate workers' compensation issues relating to the availability and affordability of re-28 29 30 insurance or excess coverage to insurers, 31 self-insurers and group self-insurers. The study 32 shall include whatever examination of the reinsurance 33 industry, including its policies, practices and regu-34 lations, as may be deemed necessary by the commis-The commission shall make its report and rec-35 sion. 36 ommendations, including any necessary legislation, to 37 the Second Regular Session of the 113th Legislature.

technical assistance.
