26	STATEMENT OF FACT

This amendment removes a penalty provision of the bill making all decisions by the board null and void if the board fails to file its financial report within 30 days after being notified of its delinquency, but retains the provision that the board will be abolished if it fails to file the report within 6 months.

	The amendment requires the Commissioner of Finance and Administration to notify the joint standing committee of the Legislature having jurisdiction over State Government of the board's failure to file the financial report.
	This amendment also requires the Board of Commis- sions to review and determine the means by which boards can be brought into compliance with the re- porting requirements of current law.
