10 11	Amend the Bill by striking out all of the title and inserting in its place the following:
12 13 14	'AN ACT to Authorize Additional Facilities for Long-term Care and Other Provisions Necessary for the Proper Operations of State Government.'
15 16 17	Further amend the Bill by striking out everything after the title and inserting in its place the following:
18 19 20	'Emergency preamble. Whereas, Acts of the Legis- lature do not become effective until 90 days after adjournment unless enacted as emergencies; and
21 22 23	Whereas, there is an immediate need to make available additional funds for the Home Base Care - Elderly Medicaid Waiver financial programs; and
24 25 26 27 28 29	Whereas, in the judgment of the Legislature, these facts create an emergency within the meaning of the Constitution of Maine and require the following legislation as immediately necessary for the preservation of the public peace, health and safety; now, therefore,
30 31	Be it enacted by the People of the State of Maine as following:
32 33 34	Sec. 1. Legislative intent. It is the intent of the Legislature to authorize the Department of Human Services to include the cost of 270 new intermediate

- care facility beds in its current services budget in the next biennium. It is further the intent of this Legislature that the Department of Human Services solicit proposals for new beds and complete the certificate of need approval for those 270 new beds as soon as possible, but, in any case, not later than July 1, 1989.
- 8 Sec. 2. Transfer authorization. For the purpose of this section, "surplus" means an excess of \$500,000 of General Funds in the Department of Human 11 Services Payments to Providers of Intermediate Care Account.
- The purpose of this request is to allow the Department of Human Services to transfer, when available, surplus funds in the Payments to Providers of
 Intermediate Care Account to the Medical Care Payments to Providers Account to aid in the payment of
 the state match for the Home Base Care Elderly
 Medicaid Waiver financial program.
- Emergency clause. In view of the emergency cited in the preamble, this Act shall take effect when approved.

1	FISCAL NOTE
2 4 5 6 7 8 9	The addition of 270 new beds will add \$5,400,000 in annual expenditures to the Medicaid program: \$1,700,000 from the General Fund and \$3,700,000 federal Medicaid matching funds. These funds, and consequently the additional appropriations, will not be needed until fiscal year 1988 because of the lead time required to approve and construct intermediate care facilities.
10 11 12	Section 2 of this amendment allows the Department of Human Services to transfer funds between accounts.'
13	STATEMENT OF FACT
14 15 16 17 18 19	This amendment adds an emergency preamble, emergency clause and authorization to the Department of Human Services to transfer surplus funds in the payments to Providers of Intermediate Care to the Medical Care Payments to Providers to aid in the state match of the Home Base Care - Elderly Medicaid waiver financial program.
