7 HOUSE AMENDMENT "H" to HOUSE AMENDMENT "A" to  
8 H.P. 1641, L.D. 2315, Bill, "AN ACT Making Supplemental  
9 Appropriations from the General Fund to Implement  
10 the Recommendations of the Visiting Committee to the  
11 University of Maine and for Other Purposes for the  
12 Fiscal Year Ending June 30, 1987."

13 Amend the amendment by adding after section 43  
14 the following:

15 'Sec. 44. Intent. It is the Legislature's intent  
16 that this supplemental budget for the university system  
17 shall be expended in the ratio as recommended to  
18 the Joint Standing Committee on Education by the  
19 trustees:

20	University of Maine at Augusta	4.6%
21	University of Maine at Farmington	6.1%
22	University of Maine at Fort Kent	.5%
23	University of Maine at Machias	3.3%
24	University of Maine at Orono	56.5%
25	University of Maine at Presque Isle	1.4%
26	University of Southern Maine	27.6%

27 It is the Legislature's intent that this supplemental  
28 budget shall be invested in expansion and enhancement  
29 of existing programs and not new programs.

30 It is the Legislature's intent that the trustees  
31 shall require of the individual campuses before authorizing  
32 expenditures under this supplemental budget detailed plans  
33 as to how the funds will be expended and the goals to be  
34 achieved for each program, including proposed measurements  
35 to evaluate the extent to which goals have been achieved.

37 The trustees shall report annually to the Legis-

1 lature an evaluation of the degree to which  
2 preestablished plans and goals were achieved.'
