'Sec. 1. Intent. It is the Legislature's intent
that this supplemental budget for the university sys-
tem shall be expended in the ratio as recommended to
the Joint Standing Committee on Education by the
trustees:

mental budget shall be invested in expansion and en-
hancement of existing programs and not new programs.

detailed plans as to how the funds will be expended
and the goals to be achieved for each program, in-
