chapter 105, subchapter II-A'

Further amend the bill in section 8 in that part
designated "§271." in subsection 2 in paragraph A in
subparagraph (2) (page 4, line 28 in L.D.) by insert-
ing after the following: "law" the following: ' ,
chapter 105, subchapter X'

Further amend the bill in section 8 in that part
designated "§271." in subsection 2 in paragraph C in
the first line (page 5, line 3 in L.D.) by inserting
after the following: "rules" the following: 'in ac-
cordance with the Maine Administrative Procedure Act,
Title 5, chapter 375,'

Further amend the bill in section 10 in that part
designated "§330." in subsection 1 in the 2nd line
(page 8, line 18 in L.D.) by inserting after the fol-
lowing: "guidelines" the following: 'by rule in ac-
cordance with the Maine Administrative Procedure Act,
Title 5, chapter 375,'
