HOUSE AMENDMENT "C" to S.P. 943, L.D. 2367,  
Bill, "AN ACT to Protect the Public Health in Rela-  
tion to Acquired Immune Deficiency Syndrome."

Amend the Bill in section 2 by striking out all  
of the 3rd line (page 3, line 10 in L.D.) and insert-  
ing in its place the following: 'PUBLIC HEALTH'

Further amend the Bill in section 2 in that part  
designated "§17001." in subsection 6 in the first  
line (page 4, line 3 in in L.D.) by striking out the  
underlined words "or anyone" twice.

Further amend the Bill in section 2 in that part  
designated "§17002." in the first paragraph in the  
3rd line (page 4, line 16 in L.D.) by striking out  
the underlined figure "25" and inserting in its place  
the underlined figure '26'

Further amend the Bill in section 2 in that part  
designated "§17002." in the first paragraph in the  
21st to 24th lines (page 4, lines 34 to 37 in L.D.)  
by striking out the following: "one from nominees  
submitted by the Maine Lesbian/Gay Political Alliance  
and one from nominees submitted by the Hemophilic  
Association"

Further amend the Bill in section 2 in that part  
designated "§17002." in the first paragraph in the  
4th line from the end (page 5, line 13 in L.D.) by  
inserting after the underlined word "counselor" the  
following: '; one member of the clergy'

Further amend the Bill in section 2 in that part  
designated "§17006." in the first paragraph in the  
3rd line (page 8, line 9 in L.D.) by striking out the

1 following: ", including attorneys' fees,"

2 STATEMENT OF FACT

3 This amendment makes the following changes in the  
4 bill:

5 1. Amends the composition of the advisory com-  
6 mittee to remove specific references for the  
7 high-risk community members and to add a member of  
8 the clergy;

9 2. Removes the requirement that attorneys' fees  
10 be paid in court cases involving violation of this  
11 Act;

12 3. Corrects a definition by changing the defined  
13 term from "person or anyone" to "person." "Person or  
14 anyone" was a phrase used in the original draft of  
15 this bill which was omitted in the new draft. The  
16 correct reference is to "person;"and

17 4. Corrects the title of the "Part" in the law.  
18 The title related to the sections of the bill which  
19 have been omitted by the new draft.
