- 3. Certified social worker independent practice. A "certified social worker - independent practice" is a person who was licensed as a certified social worker and permitted to engage in the independent practice of social work pursuant to section 7052, before January 1, 1985.
- 4. Clinical setting. A "clinical setting" is a setting where mental disorders are evaluated, prevented, diagnosed and treated using psychosocial evaluation.
- 5. Consultation. "Consultation" is regularly scheduled face-to-face case discussion and evaluation focusing on raw data, goals and objectives from social worker's practice.
- 6. Licensed clinical social worker. A "licensed clinical social worker" is a person who has received a license as a clinical social worker from the board.
- 7. Licensed master social worker. A "licensed master social worker" is a person who has received a license as a master social worker from the board.
- 8. Licensed social worker. A "licensed social worker" is a person who has received a license as a 24 licensed social worker from the board.
- 26 9. Private practice. "Private practice" is practicing social work on a self-employed basis. 27
 - 10. Psychosocial evaluation. "Psychosocial evaluation" includes the determination and examination by social workers of the psychosocial situation of an individual or group related to interpersonal and intrapersonal stress, family background, family interaction, living arrangements and socioeconomic problems and treatment, evaluation, plans and goals, including the diagnosis of mental illness and emotional disorders for the purpose of treatment and therapeutic intervention, but excluding the diagnosis of organic mental illness or treatment of any illness by organic therapy, to the extent permitted by the

licensure provision of this chapter. In the process of making a diagnosis and formulating a treatment plan for mental illness or emotional disorder, the social worker shall assure, consistent with rules to be promulgated by the board, that the person is examined by a physician and may take into account the physician's opinion in forming the psychosocial eval-uation. When a person has been seen by a physician within 3 months prior to seeking mental health treatment, a telephone conversation between that physician and the social worker may be held in lieu of the ex-amination required by this subsection. The medical visit or the telephone conversation shall be documented in the clinical records of the person. This requirement shall apply only in cases where there is a presence of psychopathology. The board shall define standards for implementation of this subsection.

- 11. Social work. "Social work" means engaging in psychosocial evaluation and intervention, including therapy, to the extent permitted by the licensure provisions of this chapter, to effect a change in the feelings, attitudes and behavior of a client, whether an individual, group or community. "Social work" also means engaging in community organization, social planning, administration and research.

Notwithstanding Title 17-A, section 4-A, any person who makes a representation to the public or uses the title of social worker, unless licensed by the board, as a licensed clinical social worker, licensed master social worker, certified social worker or a licensed social worker, shall be subject to a fine of not less than \$50 nor more than \$500. Any person performing the functions of a social worker as a part of a profession or occupation or in a voluntary capacity is not subject to this section.

Except at the request of, or with the consent of, the client, no person registered licensed under this chapter shall may be required to testify in any civil or criminal action, suit or proceeding at law or equity respecting any information which he may have acquired in providing social work services to client in a professional and contractual capacity if that information was necessary to enable him to furnish professional social work services to the client. However, when the physical or mental condition of the client is an issue in that action, suit or proceeding when a court in the exercise of sound discretion deems the disclosure necessary to the proper administration of justice, no information communicated to, otherwise learned by, that registered licensed person in connection with the provision of social work services shall may be privileged and disclosure may be required.

Nothing in this section that may prohibit disclosure by a person registered licensed under this chapter of information concerning a client when that disclosure is required by law and nothing in this section shall may modify or affect the provisions of Title 22, sections 4011 to 4015.

§7026. State Board of Social Worker Registration

The State Board of Social Worker Registration, as established by Title 5, section 12004, subsection 1, and within the Department of Business, Occupational and Professional Regulation, shall administer this chapter. The board shall consist of 8 7 members appointed by the Governor. Four members of the board shall be certified social workers, 2 shall be registered social workers, one shall be an associate social worker Three members of the board shall be licensed clinical social workers, licensed master social workers or certified social workers — independent practice, at least one of whom must be practicing social work in a nonclinical setting; 2 shall be

- licensed social workers and there shall be a 2 public member members. Each level of licensure shall be represented on the board. In addition, board members shall meet the qualifications required under section 7027.
- Appointments shall be for 3-year terms, except that no more than 3 members' terms may expire in any one calendar year and appointments for terms of less than 3 years may be made in order to comply with this limitation. No person may be eligible to serve more than 3 2 full consecutive terms, provided that for this purpose only a period actually served which exceeds 1/2 of the 3-year term shall be deemed a full term. Upon expiration of a member's term, he shall serve until his successor is qualified and appointed. The successor's term shall be 3 years from the date of the expiration, regardless of the date of his appointment. Any vacancy occurring prior to the expiration of the specified term shall be filled by appointment for the unexpired term.
- Prior to the filling of any vacancies, the Governor may solicit recommendations of candidates from the Maine Chapter of the National Association of Social Workers and such other social welfare organizations as he deems appropriate.

Members of the board shall be residents of this State, and shall be trustworthy and competent to fulfill the responsibilities imposed by this chapter. To be eligible for a license to practice as a elinieal secial worker and for certification as a certified secial worker, registered social worker or an associate social worker social work at any level, an applicant shall be at least 18 years of age and a resident of this State and shall satisfactorily pass any examination as the board may prescribe by its rules. Each applicant shall demonstrate that he is trustworthy and competence to engage in the practice of social work in such a manner as to safeguard the interests of the public.

The following shall be considered as minimum evidence satisfactory to the board that an applicant is qualified for registration and certification as a clinical, certified, registered or associate social worker, respectively licensure under this chapter.

- Licensed clinical social worker. As a licensed clinical social worker, an applicant shall have received either a masters or doctoral degree in social work or social welfare from an accredited educational institution; in a clinical concentration and have subsequently completed 2 supervised social work experience with 96 hours of consultation in a clinical setting or shall have received a masters or doctoral degree in social work in a nonclinical concentration from an accredited educational institution and have subsequently completed 4 years of social work experience with 192 hours of consultation in a clinical setting, shall have demonstrated to the satisfaction of the board adherence to ethics of the social work profession and shall have successfully completed the examination prescribed by the board. The board shall issue rules defining the clinical experience required for this level of licensure.
- 2. <u>Licensed master social worker</u>. As a eertified <u>licensed master</u> social worker, an applicant shall have received either a masters or doctoral de-

gree in social work or social welfare from an accredited educational institution, shall have demonstrated to the satisfaction of the board adherence to the ethics of the social work profession and shall have successfully completed the examinations examination prescribed by the board. After meeting these qualifications, the applicant shall receive a "licensed master social worker" license. In addition, any person wishing to practice social work in a clinical setting shall receive a "licensed master social worker", conditional "licensed master social worker, conditional" license.

- 3. Licensed social worker. As a registered licensed social worker, an applicant shall have received a bachelor's degree in social work or social welfare from an accredited educational institution, shall have been employed in social work for a period of at least one year subsequent to the receipt of a bachelor's degree; shall have demonstrated to the satisfaction of the board adherence to the ethics of the social worker profession and shall have successfully completed the examination prescribed by the board. The board shall issue rules by which an individual who has a bachelors' degree in an area other than social work or social welfare may be eligible for a license.
- 4. Associate social worker. As an associate social worker, an applicant shall have been employed in social work for not less than 6 years, or shall have received a bachelor's degree from an accredited educational institution and shall have been employed in social work for not less than 2 years, shall have demonstrated to the satisfaction of the board adherence to the ethics of the social work profession and shall have successfully completed the examination prescribed by the board.

Any person having the necessary qualifications prescribed in this chapter to entitle him to registration licensure as a licensed clinical, certified, registered or associate social worker licensed master or licensed social worker shall be eligible for that registration license though he may not be practicing his profession at the time of making the application.

Any person may register a complaint against any eertified, registered or associate social worker <u>licensed at any level</u>. Any complaints shall be in writing, shall be sworn to by the person making them and shall be filed with the secretary of the board.

The board, for reasons it may deem sufficient, may reissue a certificate of registration as a certified, registered or associate social worker license to any person whose certificate of registration license has been revoked, provided that 5 or more members of the board vote in favor of that reissuance. A new certificate of registration as a certified, registered or associate social worker, license to replace any certificate license revoked, lost, destroyed or mutilated, may be issued, subject to the rules of the board. A charge of \$3 shall be made for that issuance.

Biennial 25 fees for renewal of registration license shall be set 26 by the board in an amount not to exceed \$50 and shall 27 be due and payable biennially on or before the 28 day of January. Every 2nd renewal shall be contingent 29 evidence of participation in a continuing pro-30 fessional education course or program as approved by 31 the board. All persons licensed, registered or certified on any level under the prior social work registration law shall be entitled to practice social work as previously authorized as long as licensure remains current.

27 STATEMENT OF FACT

The purpose of this new draft is to make clear that use of the title of "social worker" is regulated. All individuals calling themselves social workers will be licensed regardless of where they are employed since all exemptions have been removed.

This new draft addresses the concerns of social workers and committee members that portions of the bill were confusing.

This new draft provides that persons who are currently licensed as certified social workers who are

	will be able to keep their current titles.
3 4 5	This new draft also provides that any person currently working in the field of social work will be licensed without an examination.
