21 22 23 24	Emergency preamble. Whereas, Acts and resolves of the Legislature do not become effective until 90 days after adjournment unless enacted as emergencies; and		
25 26 27 28 29 30	Whereas, the unforeseen jail personnel costs for Kennebec County forced Kennebec County to make addi- tional expenditures in the jail budget, the district attorney expenses and an error in the original 1986 budget and unforeseen expenditures in social securi- ty, workers compensation and related line items; and		
31 32 33	Whereas, the population of prisoners in the Ken- nebec County Jail has increased and the above unfore- seen expenditures were necessary; and		
34 35 36	Whereas, these expenses could not have been fore- seen in the original Kennebec County budget but must now be met as soon as possible; and

1 Whereas, in the judgment of the Legislature, 2 these facts create an emergency within the meaning of 3 the Constitution of Maine and require the following 4 legislation as immediately necessary for the preser-5 vation of the public peace, health and safety; now, 6 therefore, be it

7 Kennebec County Commissioners; reimbursement for 8 overdrafts authorized. Resolved: That the Kennebec 9 County Commissioners are authorized to expend from 10 the Kennebec County surplus account and unanticipated 11 excess revenues the sum of \$130,000 to meet over-12 drafts in the following departmental accounts:
