16	The Secretary of State may establish and operate
17	a central filing system to record and provide notice
18	of financing statements evidencing security interests
19	in farm products. For this purpose, the Secretary of
20	State may adopt rules, in accordance with the Maine
21	Administrative Procedure Act, chapter 375, subchapter
22	II, establish procedures and adopt a schedule of fees
23	in conjunction with filing, registering, providing
24	notices and other services performed by the Secretary
25	of State in carrying out this section.
26	Receipt of notice by a registered buyer entitled
