COMMITTEE AMENDMENT "A" to H.P. 129, L.D. 155,
Bill, "AN ACT to Recodify the Liquor Laws."

Amend the bill in Part A in section 1 in that
part designated "§88-A." by striking out all of sub-
section 6 and inserting in its place the following:

'6. Penalty. Any person who violates subsection
5 commits a Class E crime.'

Further amend the bill in Part A in section 4 in
that part designated "§2." by striking out all of
subsection 12 and inserting in its place the follow-
ing:

'12. Fortified wine. "Fortified wine" means
wine to which spirits have been added and which con-
tains more than 14.5% alcohol by volume.'

Further amend the bill in Part A in section 4 in
that part designated "§2." by striking out all of
subsection 21 and inserting in its place the follow-
ing:

'21. Municipal officers. "Municipal officers"
means the mayor and aldermen or councillors of a
city, the selectmen or councillors of a town and the
assessors of plantations.'

Further amend the bill in Part A in section 4 in
that part designated "§2." by striking out all of
subsection 22 and inserting in its place the follow-
ing:

'22. Municipality. "Municipality" means a city,
town or plantation.'

1 Further amend the bill in Part A in section 4 in
2 that part designated "§2." in subsection 27 in para-
3 graph A in the 2nd line (page 12, line 27 in L.D.) by
4 inserting after the underlined word "liquor" the fol-
5 lowing: 'in the original containers'

6 Further amend the bill in Part A in section 4 in
7 that part designated "§2." by striking out all of
8 subsection 36 and inserting in its place the follow-
9 ing:

10 '36. Wine. "Wine" means any liquor, produced by
11 natural fermentation, containing no more than 14.5%
12 alcohol by volume, including, but not limited to, ta-
13 ble wine, sparkling wines and beverages containing
14 wine to which no spirits have been added.'

15 Further amend the bill in Part A in section 4 in
16 that part designated "§62." in subsection 4 in the
17 first line (page 21, line 27 in L.D.) by striking out
18 the underlined word "alcohol" and inserting in its
19 place the underline word 'liquor' and in the last
20 line (page 21, line 29 in L.D.) by striking out the
21 underlined word "alcohol" and inserting in its place
22 the underlined word 'liquor'

23 Further amend the bill in Part A in section 4 in
24 that part designated "§122." by adding at the end of
25 subsection 1 the following: 'The petition must be ad-
26 ressed to and received by the Secretary of State at
27 least 21 days before holding any primary, special,
28 statewide or general election in the unincorporated
29 place.'

30 Further amend the bill in Part A in section 4 in
31 that part designated "§351." in subsection 1 in the
32 last 4 lines (page 32, lines 28 to 31 in L.D.) by
33 striking out the following: ", measured from the main
34 entrance of the state store to the main entrance of
35 the school, church, chapel or parish house"

36 Further amend the bill in Part A in section 4 by

1 striking out all of the caption "CHAPTER 23" (page
2 45, line 27 in L.D.) and inserting in its place the
3 following: 'CHAPTER 27'

4 Further amend the bill in Part A in section 4 in
5 chapter 33 by striking out all of the 2nd line (page
6 61, line 29 in L.D.) and inserting in its place the
7 following: 'REVOCATION AND SUSPENSION'

8 Further amend the bill in Part A in section 4 by
9 inserting a new line after the caption "GENERAL
10 CONDITIONS" (page 76, line 31 in L.D.) to read:
11 '§1051. Licenses generally'

12 Further amend the bill in Part A in section 4 in
13 chapter 43, subchapter I in subsection 2 in the 4th
14 line (page 77, line 10 in L.D.) by striking out the
15 underlined words "town or city" and inserting in
16 their place the underlined word 'municipality'

17 Further amend the bill in Part A in section 4 in
18 that part designated "§1363." in subsection 2 in par-
19 agraph A in the last line (page 106, line 18 in L.D.)
20 by adding after the underlined word "sold" the fol-
21 lowing: 'and delivered'

22 Further amend the bill in Part A in section 4 in
23 chapter 51, subchapter IV, by striking out all of the
24 2nd line (page 107, line 13 in L.D.) and inserting in
25 its place the following: 'SPECIAL WAREHOUSES'

26 Further amend the bill in Part A in section 4 in
27 that part designated "§1405." in subsection 3 in the
28 2nd line (page 112, line 33 in L.D.) by striking out
29 the underlined figure "1" and inserting in its place
30 the underlined figure '2'

31 Further amend the bill in Part A in section 4 in
32 that part designated "§1407." in subsection 1 in the
33 first line (page 114, line 30 in L.D.) by striking
34 out the following: "The" and inserting in its place
35 the following: 'Except as provided in chapter 57,

1 the' and in the 4th line (page 114, line 33 in L.D.)
2 by inserting before the underlined word "liquor" the
3 following: 'wine or malt' and in the 7th line (page
4 114, line 36 in L.D.) by inserting before the under-
5 lined word "liquor" the following: 'wine or malt'

6 Further amend the bill in Part A in section 4 in
7 that part designated "§2053." in subsection 1 in the
8 4th line (page 133, line 36 in L.D.) by striking out
9 the underlined figure "1001" and inserting the under-
10 lined figure '2052'

11 Further amend the bill in Part A in section 4 in
12 that part designated "§2073." in subsection 3 in par-
13 agraph E by adding after subparagraph (1) the follow-
14 ing: '(2) To industrial establishments in the State
15 for industrial uses;' and by renumbering
16 subparagraphs (2) to (4) to be subparagraphs (3) to
17 (5)

18 Further amend the bill in Part A in section 4 in
19 Part 7 by striking out all of the 3rd line (page 142,
20 line 2 in L.D.) and inserting in its place the fol-
21 lowing: 'CHAPTER 91'

23 This amendment corrects technical errors made in
24 recodifying Title 28.
