7 SENATE AMENDMENT "B" to COMMITTEE AMENDMENT "A" 8 to H.P. 150, L.D. 191, Bill, "AN ACT to Amend Cer-9 tain Motor Vehicle Laws."

10 Amend the amendment in section 3 by striking out 11 everything after the amending clause and inserting in 12 its place the following:

13 'Any person, partnership or corporation, owning 14 leasing and applying for registration of a semior 15 trailer or trailer, may make application upon a blank 16 supplied by the Secretary of State for a semipermanent registration plate to be displayed on the rear 17 of the semitrailer or trailer so owned or leased. The 18 persons, partnerships or corporations must be Maine 19 residents or if they are not, must have a place of 20 business and an address in Maine and-must-operate-and 21 22 register-a-truck-tractor-in-the-State-of-Maine or a 23 designated agent or representative resident in Maine. 24 of State shall furnish the person, The Secretary 25 partnership or corporation with one semipermanent 26 plate for each such semitrailer or trailer, which 27 plate shall expire either at the end of each 8-year 28 12-year semipermanent plate program or, in the or 29 case of new semitrailers or new trailers, at the end the 12th registration year following the year of 30 of 31 issuance, depending upon the type of registration requested by the applicant. The fee shall be $\$ \pm \theta$ 32 \$15 for each semitrailer registration and \$5 \$7.50 for 33 34 each trailer registration for not more than 2,000 35 pounds, GVW, for each registration year, or portion 36 thereof; and there shall be no refund of payment of 37 such fee, except that when a plate is returned within 38 120 days of the effective date of that year's regis-39 tration with an affidavit that the plate has never been used and the Secretary of State is satisfied 40 41 that the plate has never been used, the pro rata
