1 AN ACT to Provide for the Appointment of the
2 Executive Director of the Maine Health
3 Care Finance Commission by the
4 Governor.

6 Be it enacted by the People of the State of Maine as
7 follows:

8 Sec. 1. 2 MRSA §6, sub-§1, as amended by PL
9 1985, c. 785, Pt. A, §1, is further amended to read:

10 1. Range 91. The salaries of the following
11 state officials and employees shall be within salary
12 range 91:

13 Commissioner of Transportation;

14 Commissioner of Conservation;

1 Director of State Development Office;
2 Commissioner of Finance;
3 Commissioner of Administration;
4 Commissioner of Educational and Cultural Ser-
5 vices;
6 Commissioner of Environmental Protection;
7 Commissioner of Human Services;
8 Commissioner of Mental Health and Mental Retarda-
9 tion;
10 Commissioner of Public Safety;
11 Commissioner of Business, Occupational and Pro-
12 fessional Regulation;
13 Commissioner of Labor;
14 Commissioner of Agriculture, Food and Rural Re-
15 sources;
16 Commissioner of Inland Fisheries and Wildlife;
17 Commissioner of Marine Resources; and
18 Commissioner of Corrections; and
19 Executive Director of the Maine Health Care Fi-
20 nance Commission.

21 Sec. 2. 2 MRSA §6-B, sub-§1, as enacted by PL
22 1983, c. 579, §1, is repealed.

23 Sec. 3. 22 MRSA §384, as amended by PL 1985, c.
24 785, Pt. B, §84, is further amended to read:

25 §384. Executive director and staff

26 The ~~commission~~ Governor shall appoint an execu-
27 tive director, who shall have had experience in the
28 organization, financing or delivery of health care
29 and who shall perform the duties delegated to him by

1 the commission. The executive director shall serve at
2 the pleasure of the ~~commission~~ Governor and his sala-
3 ry shall be set by the ~~commission~~ Governor within the
4 range established by Title 2, section 6-B 6. The ex-
5 ecutive director shall appoint a deputy director, who
6 shall perform the duties delegated to him by the ex-
7 ecutive director. The deputy director shall serve at
8 the pleasure of the executive director and his salary
9 shall be set by the executive director within the
10 range established by Title 2, section 6. The commis-
11 sion may employ such other staff as it deems neces-
12 sary. The appointment and compensation of such other
13 staff shall be subject to the Civil Service Law.

STATEMENT OF FACT

15 The purpose of this bill is to provide that the
16 Executive Director of the Maine Health Care Finance
17 Commission is appointed by the Governor rather than
18 by the commission.
