7 COMMITTEE AMENDMENT "A" to S.P. 88, L.D. 209, 8 Bill, "AN ACT to Repeal the Sunset Provision of the 9 Social Workers Freedom of Choice Law."

10 Amend the bill by inserting before the statement 11 of fact the following:

12 'Sec. 3. 24-A MRSA §2835, sub-§1, as amended by 13 PL 1983, c. 805, §3, is further amended to read:

14 1. Notwithstanding any provision of a health in-15 surance policy subject to this chapter, whenever the 16 policy provides for payment or reimbursement for ser-17 vices which are within the lawful scope of practice 18 of a psychologist licensed to practice in this State, 19 a certified social worker licensed for the indepen-20 dent practice of social work in this State who has at least a masters degree in social work from an accred-21 22 ited educational institution, has been employed in social work for at least 2 years, and who, after Jan-23 24 uary 1, 1985, must be licensed as a clinical social 25 worker in this State, or a licensed nurse who is certified by the American Nurses' Association as a clin-26 27 ical specialist in adult psychiatric and mental 28 health nursing or as a clinical specialist in child 29 and adolescent psychiatric and mental health nursing, 30 any person covered by the policy shall be entitled to 31 reimbursement for these services if the services are 32 performed by a physician, a psychologist licensed to 33 practice in this State, certified social worker li-34 censed for independent practice in this State who has 35 at least a masters degree in social work from an ac-36 credited educational institution, who has been em-37 ployed in social work for at least 2 years, and who, 38 after January 1, 1985, must be licensed as a clinical 39 social worker in this State, or a licensed nurse cer-40 tified by the American Nurses' Association as a clin-

Payment or reimbursement for services ren-8 dered by clinical social workers licensed in this 9 State shall not be conditioned upon prior diagnosis 10 referral by a physician or other health care proor 11 fessional, except in cases where diagnosis of the 12 condition for which the services are rendered is beyond the scope of their licensure.
