15 16 17 18	Further amend the bill in section 6 in paragraph A by striking out all of the 16th to 18th lines (page 3, lines 14 to 16 in L.D.) and inserting in their place the following:

22 23	Further amend the bill by striking out all of section 8 and inserting in its place the following:
24 25	'Sec. 8. 36 MRSA \$1504, sub-\$5-A is enacted to read:

Any owner who has paid the excise tax for a watercraft which is transferred in the same tax year is entitled to a credit to the maximum amount of the tax previously paid in that year for any number of watercraft, regardless of the number of transfers which may be required of him in the same tax year. The credit shall be allowed in any place in which the excise tax is payable.

 Further amend the bill in section 9 by striking out all of paragraph F (page 5, lines 26 and 27 in L.D.)
- 5 STATEMENT OF FACT
- This amendment provides that fines for failure to 6 display an excise tax decal will be paid to the mu-7 nicipality where the excise tax is owed rather than 8 9 the State. It corrects an error in the new tax table to reflect the intent to increase taxes for wa-10 tercraft with a length of 23 feet or more. It re-11 moves section 8 and replaces it with a provision al-12 lowing a trade-in credit against the tax for water-13 craft which are traded in during the tax year. It 14 also removes a provision which would have extended enforcement of the tax to any law enforcement offi-15 16 17 cer.
