Amend the Bill by inserting at the beginning of  
the first line after the enacting clause (page 1,  
line 6 in L.D.) the following: 'Sec. 1.'

Further amend the Bill in that part designated  
"§1752." in subsection 2 by striking out all of para-  
graph C and inserting in its place the following:

'C. This subsection does not apply to motor ve-  
hicles registered as farm motor vehicles, vehi-  
cles used for farming purposes or vehicles en-  
gaged in plowing and sanding public ways.'

Further amend the Bill in that part designated  
"§1752." in subsection 2 in the first line (page 2,  
line 36 in L.D.) by striking out the following:  
"2. Penalty." and inserting in its place the follow-  
ing: '3. Penalty.'
