STATEMENT OF FACT

In Maine, there are 23 hospices providing coverage in all counties statewide. The majority of these programs are volunteer, community-based organizations currently supported solely by donations. One-half of these programs do not have any paid staff.

20 Services include, but are not limited to, 21 respite, transportation, community education, 22 bereavement support, information and referral and 23 family household support. Services are provided 24 through a structured network of trained volunteers 25 and professionals.

26 The Maine Hospice Council is a broad-based mem-27 bership organization whose purpose is to foster the 28 availability of hospice services throughout Maine. 29 Activities of the council include technical assist-30 ance to new and existing hospices, consumer and 31 provider education and networking to integrate hospice concepts and services with existing health 32 33 and social service delivery systems whenever possi-34 ble.

This bill appropriates \$250,000 each year of the biennium to provide partial support for these services.
